Dear KSD Community,

Last night, the board was very pleased to have the opportunity to vote unanimously to rescind 2.5 layoff notices for the 2020-21 school year. Other reassignments occurred due to retirements and departures, but unfortunately, we were not able to rescind all layoff notices at this time and we feel profoundly saddened.

We also want to take the opportunity to clear up any potential misunderstanding on Bacich class size numbers for our 2020-21 school year based on an enrollment and staffing report provided by Superintendent Liz Schott during our [April 29th board meeting](#). During last week's meeting, staff presented class size numbers based on current enrollment, new registrations, teacher retirements, and layoffs made during our budget reductions.

In our board meeting last night, a 2020-21 Bacich class size [update](#) was presented with scenarios for adding back teachers (to replace departures and retirements) as well as the associated [costs](#). We anticipated that some layoff notices might be able to be rescinded based on retirements or other departures as was noted in our [February 13th letter to the community](#), and we were pleased this came to fruition. As the result of our Board vote last night, estimated class sizes at Bacich for the 2020-21 school year have been returned to more expected levels.

Given that enrollment is always in flux at this time of year, particularly with the COVID-19 pandemic at play, our school administrators at both Bacich and Kent are closely monitoring registrations. The board will continue to hear regular reports on enrollment and registrations, and will make further adjustments to school structures and class sizes as deemed necessary.
